TACOMA PUBLIC SCHOOLS

- Design-Build Recertification
- The first K-12 school district to achieve DB Certification. One of the largest certified public bodies in WA.
- Successfully completed 1 DB project, and have 5 DB Projects in progress totaling \$221M
- District continues to exceed their own inclusion & apprenticeship goals by nearly 50%.
- District staff and consultant partners have extensive D/B experience.
- Funding is in place for current and future projects.

BREMERTON SCHOOL DISTRICT – DESIGN-BUILD PROJECT

- West Sound Technical Skills Center Improvements
- Project Cost: \$82.6M
