  - It's best to make sure the whole Design-Build Team knows what type of progressive Design-Build the projects is being used. It will help to keep everyone on the same track.

- 25 out of the 413 injunction fish barriers in close proximity are bundled to be replaced with fish passible structures that include streambed grading, restoration of fish habitat, roadway construction, drainage, and various traffic safety elements.
