






Mission:

Policy Workgroups

1.Retainage and Bonding 2. Equitable Distribution 3. Developing and maintaining Rosters 4.Contracting Thresholds, Automatic Cost Escalation 5. Two-Tier system for contracting agencies 6.Administratively Transparent and Efficient

Recommendations

- I. Consistent Thresholds (Port and Special Purpose Districts)
- 2. No Automatic Threshold Escalation. CPARB to recommend increases to the Legislature every 5 years, based on actual escalation.
- 3. Provide Clarity that WSST is not included in Threshold
- 4. Direct Buy (waive competition) for Public Works Contracts Under \$50,000
- 5. Invitation to Bid Provided to Entire Roster. Eliminate the Pick 3 or 5 to Ensure Equal Access and Opportunity.
- 6. No bonds or retainage required for Projects under \$5,000

More Deliberation Needed

- 2. Guardrails for Direct Buy Under \$50,000
- 3. Concept of a portion of Small Works (under \$X) reserved for Certified Small Businesses.
