Below is a link to the Joint Legislative Audit and Review Committee's (JLARC) Alternative Public Works Contracting Procedures Sunset Review. You also may provide additional comments after responding specifically to the recommendations. To finalize the report, we are requesting your response by November 6, 2020.
