In response to recent construction reports and regional escalation exceeding predictions, we have developed several cost savings approaches towards delivery of our projects, including grouping three of our elementary school projects to be designed by one architect and bid to a single Contractor. We have accordingly re-assigned our project management support teams in response to this and other changes, and accordingly Ray Vefik will be the Project Manager for this package of three schools. In combining these schools to be approached as a single project, we will be able to capitalize on design and construction efficiencies through project similarities and economies of scale. Given the short design and construction phases for these projects, engaging a GCCM contractor in design will be essential to the successful delivery of these projects.
