Matt Lubbers with BN Builders offered support for this application. He is working with both WWU team members and the Perkins & Will representatives on another project and they have proved to be great collaborative partners. The team fully understands the GC/CM method and he feels this projects will be a success even with the challenges they face.

 - Need for integrated design and construction team during design
 - Complex technical requirements for site and systems, including poor foundation conditions across entire site, and possible contamination
- Discussed Lesson Learned

Public Comment:

Matt Lubbers with BN Builders offered support for this application. He has worked with both the school district and McGranahan and feels they are both proficient and really understand the GC/CM delivery model. Even though there weren't stated inclusion goals, the Star Lake Totem project is at a little over 24% for subcontracting diverse certified firms. He feels the Olympic View project is ideal for GC/CM with its phased permitting and construction, the phased bid packaging, the aggressive schedule and budget, and the need to bring on subcontractors early in the pre-construction to help with the soil issues and GOP constraints.

Dave Flynn with Cornerstone General Contractors is currently working with Federal Way School District on their Thomas Jefferson High School Project which is going successfully and has a diversity participation just above 12%. He feels the Federal Way School District and McGranahan Architects are very adept at doing GC/CM projects. He feels this is a great project for GC/CM and urges approval of the project.

Deliberation:

The panel shared some concern about the asbestos mediation and hopes the School District will utilize the GC/CM to contain and address it. The project meets the RCW requirements. The use of progressive Design-Build was encouraged for the School District to look into for similar non-historic projects that are for unoccupied sites, as it would allow them to stay involved, increase cost savings to the taxpayers, and have more control of the diversity and inclusion participation. The MWBE representative stressed the need for sharing success numbers to satisfy MWBE requirements. Applicants should be willing to show their efforts to satisfy those requirements. Over all the panel was satisfied that the project meets the requirements for GC/CM.

Linneth Riley Hall made the motion to approve this project application. Jim Dugan seconded the motion. Unanimous Approved 8/8

- District emphasizes equity in procurement, adopted Governor's goals for W/MBE participation, has exceeded own goals on previous D/B projects.
- District staff and consultants have recent D/B experience on several projects.
- Project meets two of the RCW requirements for D/B:
 - Opportunity for innovation and efficiencies between designer and builder. Site, structure and systems

Presentation:

- Install and/or replace a variety of artificial surfaces for a range of athletic activities at six sites. \$26.3 M. Total project budget
- District emphasizes equity in procurement, adopted Governor's goals for W/MBE participation, has exceeded own goals on previous D/B projects
- Most District staff and all consultants have recent D/B experience on several projects.
- Project meets two of the RCW requirements for D/B:
 - Opportunity for innovation and efficiencies between designer and builder.
 - Significant savings in project delivery time.

Public Comment:

Dan Cody with Parametrix: Dan stated that one of lessons he has learned doing Design-Build and working with a particular client is trust. Morris goes out and hires highly qualified people and then trusts them to make good judgements on behalf of his district. It's that trust piece that is really important to make the process work. Not all clients are able to trust at the same level that he does.

Layne Alfonso with GeoEngineers: Layne supports this project. As a parent with kids in this district, being a community member and business owner in Tacoma, he feels the sports fields are amazing. The fields that have been established over the last couple of years are in use all year around and nearly every hour of the day. He feels that being able to group these projects together to get the most innovation towards enhancing the community is going to have huge impacts. Especially with Covid impacting everyone, the sports fields allow children to get outside and play safely. This is a great opportunity to really demonstrate what a system-wide approach to play fields can really do.

Dan Mundle with Korsmo Construction: Dan would like to express his support of this project and team. Korsmo has worked with Tacoma Public Schools and felt Boze was a great success.

Deliberation:

There was very little deliberation. A lessons learned from Linneth suggests that one panel should review multiple projects by the same applicant. Scheduling concurrently would give the panel more insight to the applicant and their abilities. It was recommended this be continued in the future. The whole panel was impressed with Tacoma Public Schools, their management, their team, their inclusiveness within the community, and look forward to them applying for DB Certification.

12:30 pm PROSSER PUBLIC HOSPITAL DISTRICT – GC/CM PROJECT

- Prosser Memorial Hospital Replacement

Panel Chair: Jeff Jurgensen

Panel: Quinn Dolan, Sherry Harris, Dave Johnson, John Palewicz, Mike Shinn, David Talcott, Kyle Twohig

Presentation:

- \$57 million project budget
- Proposed new two story hospital of 70,000 sf, new medical office building and clinic of 15,000 sf, maintenance building of 1,500 sf and site improvements
- Funding sources mainly USDA Rural Development and Direct Loans, has not been secured yet
- NV5 selected as PM consultant, Perkins Coie is legal consultant, bc Design Group is architect Hospital staff, PM consultant and Architect do not have WA GC/CM experience.
- Selection process flawed and seemed rushed
- Project fits criteria for GC/CM however, the owner readiness and understanding per the criteria in Part C of Evaluation form *(re: necessary experience or team)* is a fail.

Public Comment:

David Slokken, J Duncan Construction: Mr. Slokken is a senior pre-construction manager and wanted to voice his support for the Prosser Memorial team in advocating for this delivery method. He feels the team's presentation shows how well this delivery method will help tackle the technical and financial challenges for this project. He also support the collaborative approach the team has taken to addressing the inherent risks in this type of project. Both the Prosser team and NV5 have his complete confidence to provide a successful project.

Brandon Potts, Bouten Construction: Brandon runs the Richmond office about 20 miles from the Prosser Memorial Hospital project site. He's worked with Prosser in the past in his former role as the Director of Capital Projects with the Kennewick School District. He feels GC/CM is the right methodology for this type of complex project. He wished to share some perspective that in eastern Washington, they have a unique and different labor pool than what is available in the larger cities. Hospitals have some specialty complex systems that are unique and even more limited in the outreaching rural areas of the state. Finding qualified contractors can be a challenge and using GC/CM can assist in gaining the best value for those qualified to get the job done all the way to the trade partners. Brandon has worked with Andrew Greene in the past and he feels the team will be adequately guided through all the legalities for a successful project.

Jeremiah Shakespeare with Swinerton Builders: He would like to echo the comments from J Duncan and Bouten, and he feels they were right on track. He is completely in support of the GC/CM delivery method for a project of this magnitude and complexity. He would like to advocate for approval of this application.

Mike Shinn: Mike pointed out for the record and everyone's benefit that even though members of the presentation team and supporting contractors have referred to CM/GC, that GC/CM in Washington is different than CM/GC in Oregon. He's not pointing intending to single anyone out, he wanted to make sure everyone is clear that there is a difference between delivery methods.

Patrick Rank with Lease Crutcher Lewis: Patrick wishes to advocate for approval of this project. He too feels this delivery method fits and suits the needs of this project.

Deliberation:

The panel expressed and discussed concerns regarding the lack of Washington GC/CM experience on the team. Additional concerns were discussed regarding how the team proposed they will get the correct information out when picking their GC/CM and subcontractors, and how they intend to handle business equity. The panel suggested the applicant bolster their team and return for the January PRC meeting to receive project approval.

Conclusion:

Mike Shinn made a motion to disapprove the project application. John Palewicz seconded the motion. Denied (6/8) 6 panelists voted to deny this project application and 2 voted to approve.

- Owner's rep firm from state of Oregon with no RCW 39.10 experience resulting in not meeting the public body requirements to achieve GC/CM approval.
- Selection process was flawed and pointed out in presentation. Did not appear to understand the issue with the process or the RCW as written. The owner team did not seem to be ready or have team to support them.

Public Comment: No Public Comments

Deliberation:

The panel felt the project meets the needs required to use GC/CM, and agrees that the team has quite a bit of project management experience, but had serious concerns that none of the project management experience was within Washington State. There were a number of references to CM/GC and different sets of procedures than what is required for GC/CM within Washington and RCW 39.10. The panel was in consensus that the applicant should bolster their team with some additional members who are familiar with RCW 39.10 and then reapply for project approval at a future PRC meeting.

Conclusion:

Mike Shinn made a motion to deny the project application. Jeff Jurgensen seconded the motion. Unanimous Denial (8/8)
