

Enterprise Agreement #01E73529 Amendment ID CTM

This amendment ("Amendment") is entered into between the parties as of the effective date identified on the signature form. It amends the Enterprise Agreement ("Agreement") #01E73529. Notwithstanding anything to the contrary, except for changes made by this Amendment, the Agreement remains unchanged. This Amendment will automatically apply to all enrollments under the Agreement, through those enrollments' expiration or termination.

How Enrolled Affiliates acquire Licenses

Section 2(c) of the Agreement is amended and replaced as follows:

c. How Enrolled Affiliates acquire Licenses.

An Enrolled Affiliate will acquire its Licenses by executing an Enrollment under which it acquires its licenses through the Washington State Department of Enterprise Services' (DES') chosen Reseller. The following additional terms and conditions shall apply to pricing and payment terms:

- a. Microsoft will invoice the Reseller based upon confidential net prices and with payment terms agreed to between Microsoft and the Reseller, and those net prices shall be proportionate and correspond to reference prices, payment schedules and other terms and conditions of each applicable Enrollment (and the terms and conditions of this Agreement which apply to each applicable Enrollment); and
- b. The Reseller will invoice the Enrolled Affiliate based upon prices and payment terms agreed to between DES and the Reseller.
