DES provided an overview of the Pritchard Rehabilitation/Expansion Validation Study. The summary included background on the building's historical significance, a summary of alternations made to the building since its construction and prior planning related to use of the Pritchard building. Mithun, the design firm leading the study, presented information on the goals of the study and the approximate schedule of work.

DES asked stakeholders to provide any initial thoughts, concerns and ideas they have in regards to the study. The group discussed:

- The stakeholder engagement process, meeting schedule and importance of stakeholder input
- History of the Pritchard Building and stakeholder connections
- Preliminary concepts for stabilizing the hillside behind the Pritchard building
 - Options reviewed include a secant (interlocking) pile wall along the top of the slope; ground improvements with a grid of piles capped with a platform; reinforcement of the west and south edges of the building with a grade beam on piles.
- Previous studies conducted on the hillside and their findings
- Needs beyond the Pritchard location for hillside stabilization and stakeholder desire to separate cost of hillside stabilization from cost of Pritchard rehabilitation/expansion options
- Consideration of current building uses and options for future uses, including need for visitor space within the building

- Considerations related to code upgrades and options for book stacks, prior alterations, and options for restoring original building features, including large windows.
- Context of Pritchard building's location and its symmetry and proportions in built dialogue with the Legislative Building and surrounding State Capitol Historic District
- Programmatic space needs for the House of Representatives and support functions
- Pritchard Rehabilitation/Expansion Validation Study project scope and goals
- Consideration that the building could have significant interior reuse adaptions and still maintain its status on the National Register of Historic Places
