## **BUSINESS MEETING:**

- Vice Chair Elections Jeff Jurgensen elected
- The Committee discussed some of the updates to RCW 39.10 and how they immediately impact how the Committee does business.
  - GC/CM Addendum and Addendum Score Sheet Drafts were discussed
  - Addendum Subcommittee formed to review the revisions to RCW 39.10.250 & 39.10.385, and bring a new draft Addendum and Score Sheet to the June 24<sup>th</sup> PRC Business Meeting for Committee Review.
  - Addendum Subcommittee will also review the GC/CM Project Application and make recommendations on its revision as well.
- The Committee Bylaws will need to be updated, but priority will be on the GC/CM Addendum and Project applications.
- The Committee was informed of the new and returning members as voted at the May CPARB meeting

## WESTERN WASHINGTON UNIVERSITY

– GC/CM PROJECT ADDENDUM (Electrical Engineering & Computer Science Facility Approved in December 2020)

- Original approval was acquired December 3, 2020.
- Requesting Alternative Subcontractor Selection Process (ASSP) for Mass Timber Structural System.
- Design Phase fees offset by schedule gains advantage of early procurement
- WWU, GC/CM & M/ECCM's committed to meet or exceed 20% DBI
- Public Benefit includes early integrated collaboration of Mass Timber Manufacturer consultants avoids conflicts during design, scheduling, and procurement.
- Meets all RCW criteria
- Unanimous Approval

## SOUND TRANSIT

– Design-Build Recertification

- Public Transportation, Originally certified for DB in 2015
- Currently have nearly \$3B invested in Design-Build projects

- Secure structure with pre-engineered building around steel cells, with detention security equipment and electronics.
- Facility to include Jail Administration, Booking, Laundry, Kitchen, Jail, Sallyport, and support spaces.
- Water and Sewer extension, grinder pump and lift station will need to be included.
- Unanimous **Denial** 
  - There are a lot of unknowns on this project without enough contingencies or time allotments to be successful.
  - Project team does not have relevant WA GC/CM experience or legal counsel to guide through the many nuances and subtleties that are unique to WA State.
  - The panel feels this project is not structured for success.

COVID is continuing to impact when we will be able to meet face to face, until that is possible the virtual meetings are working well.

  - a. Application and review forms were developed for already approved GC/CM projects as well as the new GC/CM project approval forms were developed where the applicants also can apply for alternative subcontractor selections at the same time as the project.
  - b. As the panels have been getting done early, we did not increase the time for a presentation and instead have left more time between presentations so we can go long if needed. The goal was to revisit the time limits after we have a sample set to review the times.
