Meeting Minutes

- Welcome and Overview
 - o Introductions
- Discussion topic: What infrastructure support do you think small/diverse businesses require to bid the state contracts?
 - The PIE Team is discussing ways to create a small business program that will help small and diverse businesses that are OMWBE certified and registered in WEBS.


- We are trying to identify what some small, diverse businesses need help and support in winning proposals. Do these businesses need support in accounting, marketing, planning, consulting, or others?
- If we can identify the top (areas of need), we can develop strategies to address these needs.
- PTAC is an agency that helps in these areas.
- We are reaching out to WSDOT regarding the success of their program to support the infrastructure of addressing these areas of concern.
- There is a support program to address the needs of the WSDOT: <u>Small Business Support</u> <u>program model-WSDOT</u>
- Mark McClurkin DES Contract Specialist the monthly "Open House" training that DES
 will give can be catered to address the gaps in the process of submitting a proposal to
 compete for a contract award or to address the "disconnects" between the Contract
 Specialists and the business owners.
- Traci Harrell, CEO/Founder/DEI Consultant of It's All Better Than Me DES has done an
 excellent job of identifying a process that may have been cumbersome (solicitation
 process) and saying here is what you need to know about that process.
- Shana Barehand (DES Business Diversity & Outreach MGR) we are looking to develop a small business support program to help businesses almost ready to do business with the state. We are focused on where we can continue to support that infrastructure to ensure that these businesses are ready to contract with the state.
- We are working very closely with the Department of Commerce, which recently released some grants to non-profits doing this work. Still, DES wants to be hyperfocused on those businesses that may need help along the areas specified in the infrastructure plan.

Supplier Diversity Policy and handbook updates

- Policy Goals
 - Remove barriers that prevent small, diverse, and veteran businesses from accessing state goods and services.
 - Establish supplier diversity requirements authorized by statute and previous Executive Orders.
 - Support and maintain the governor's subcabinet tools for equity in public spending.
- Disparity Study
 - Working closely with OMWBE to support agency compliance with Executive Order 22-01 and the Supplier Diversity Policy.
 - SD Policy addresses all the Disparity Study recommendations cumulatively with OMWBE.
 - Seven of the recommendations addressed by DES SD Policy/Handbook
 - Four of the recommendations addressed by other DES practices and policies.
 - Five of the recommendations are addressed by OMWBE.
- **Tracy Harrel to invite Drew to present on SD Policy and Shana and DES Director Tara Smith to a future "Black Collective" meeting.

- Disparity Study Outreach
 - We sought feedback in drafting the SD Policy and its concept, which was used to develop the policy timeline in 2019.
 - We received more than 1400 induvial comments on the draft documents in 2021.
 - We worked extensively with several partners throughout the process, including the Business Diversity Advisory Group (BDAG), Procurement Customer Advisory Group (PCAG), the Office of Minority and Women's Business Enterprises (OMWBE), the Department of Veteran's Affairs (DVA), the Office of Equity, and the Governor's Subcabinet on Business Diversity.

- Tools for Procurement Staff
 - Training video for procurement staff and agency leaders will explain policy and interactive handbook.
 - Interactive handbook will give procurement staff step-by-step instructions for embedding supplier diversity requirements in all aspects of goods and services procurements. DES statewide contracts are undergoing the same process.
- Executive leadership requirements
 - Designate one or more agency leaders responsible for increasing agency spending with small, diverse, and veteran-owned businesses.
 - Publicly post the name and contact information of these leaders.
 - Christine Warnock (DES Policy Team) DES also has the authority to delegate "purchase authority" to all state agencies, commissions, etc., and DES will be looking at agencies' compliance with the Supplier Diversity Policy. If agencies are non-compliant, they could have their "purchase authority" reduced or suspended.
- BDAG Recommendations and Updates -Shana Barehand (DES Business Diversity & Outreach)
 - Unbundling is the division of a large contract(s) into more minor agreements and can be done using the parameters of "region" and or "job scope."

- Standard formats Every solicitation shall have a standard 1-page cover sheet to include Key dates and budget if known. Forms should be consistent, and we hope to work with other agencies to achieve consistency across different agencies.
- Outreach Policy Anastassia Hunte Gardner is leading our "outreach guidance."
 Our priority is doing outreach with every single solicitation. We are researching small and diverse businesses to solicit and provide them (small businesses) with the knowledge that we will be requesting for upcoming goods and services.
- Awards notices we post the ASB "Apparent Successful Bidder" in WEBS, and winning bids are also published on the statewide portal.
- Inclusive procurement practices we have worked very closely with our Contract Specialists to help them identify areas that are barriers to smaller businesses. This language is also in our policies. It will be more fully developed in the policy handbook.
- Comment from Lee Mozena (Zena Consulting LLC) there is an opportunity to educate in the monthly training; regarding the partnership aspect (jointventure) and potential support on how to partner and pursue those "unbundled" contracts.
- Capacity how will we evaluate the overall capacity of the bidding team, whether there are partnerships, joint ventures, sub-contracting agreements, etc.? We need to train our evaluators to view those partnerships as having "full capacity."
- Non-cost factors we are already using small and veteran priority points. We have determined that Federal funds cannot be used for contracts with small and veteran points because an "in-state preference" is used in those contracts.
- OMWBE certification we require that businesses be OMWBE certified through the SD Policy and that we search for businesses using the OMWBE database.
- Micro/mini preference DES is looking at the (micro/mini) preference as Federal funds may not be used when the state "small and veteran" points are awarded on contracts.
