II. Highlights from RFQ

- A. The highlights we will be covering today are from the RFQ. See the DES website listed in the RFQ for this document and others associated to this selection.
- B. The selection is for an Architect for Predesign Services only.
- C. History:
 - While the Lodge is not officially on the State's registry of historic places, it was originally constructed in the 1930's (or earlier) as part of the Fort George Wright army post.
 - It is thought it served as an officer's mess hall and club house.
 - In 1967, a portion of the fort grounds, including the Lodge, was deeded for educational purposes. It first became the second campus for Spokane Community College. In 1970, it transitioned to Spokane Falls Community College and became a separate college in the CCS District.

D. Future Purpose:

- Current CCS District Administration, Business and HR office functions are located in River Point One – Spokane's University District east of downtown.
- Historically these functions were located on the campuses. With this project, CCS would like to get back to this model of operation.

E. Project Goals:

- This project provides a unique challenge to preserve the architecturally historic nature of the facility while modernizing into an up-to-date work center to serve the needs of the CCS District administrative functions.
- Increase the accessibility and welcoming feel of the facility by improvements to landscape, site, and campus access; may include working with the City of Spokane to implement traffic calming strategies to assist with tying the building to the main campus across Whistalks Way.
- Enhance the building and site to better promote the location and views as well as usability of the area in a safe and secure manner.
- Increase student/staff access and interaction creating a sense of continuity and connection with the campus.
- Utilize high efficiency building systems to support meeting the goals of the State's Clean Building Act and other decarbonization legislation.
- F. Firms submitting SOQ's should have a strong background in the innovative design and modernization of historic facilities, as well as, a robust strategy to uncover existing conditions and successfully work within the constraints of inexact record documents.

- G. Schedule highlights:
 - 1. Statement of Qualifications are due on Thursday, July 13, 2023 prior to 2:00 pm.
 - 2. Short-listed firms will be selected and notified the Week of July 17th.
 - 3. Interviews will be scheduled on Friday, July 28, 2023 in the morning.
 - 4. Selections will be announced the Week of July 31st.
 - 5. Architectural Agreement will be executed mid-August 2023.
- H. Interested firms are responsible for checking the DES website for any changes to this solicitation. Information from this meeting will be posted to the website.
- I. See the RFQ for SOQ for detailed requirements.
- J. DES <u>only</u> accepts electronic submittals. All electronic submittals must be uploaded and received no later than the date and time specified. See the RFQ for the secure access point for uploading your SOQ.

- N. The selection process will consist of two phases: Phase 1 SOQ Evaluation and Phase 2 Oral Interviews. The RFQ includes weighted evaluation criteria for both Phases.
- O. Interviews include the following time periods:
 - 1. Presentation 30 minutes
 - 2. Q & A 20 minutes
 - 3. Closing 5 minutes
 - 4. Set-up and break-down need to occur within the total 55 minute time period.
- P. The successful firm and its subconsultants must register and create an account with the DES Diversity Compliance program B2Gnow.
- Q. Evaluation and Scoring is detailed in the RFQ.
- R. The DES standard Engineering and Architectural Services Agreement will be used.
