




- SITUATED 10 MILES NORTH OF SEATTLE

Shoreline Community College potential projects, with a biennium budget of \$4million, include:

- Various Tenant Improvements throughout the campus – space renovation and development, and a new elevator.
- Recondition failed concrete surfaces to a pedestrian access bridge & shear wall.
- Repair drainage under building 1500.
- Repair Orchestra pit foundation drainage system.
- Replacement of failed door operators and doors.
- Replace obsolete boilers & circulation pumps.
- Repair failing air handlers.
- Repairs to various roofs.
- Replace Three Phase Transformer.
- Replace multiple Potable Water Meters.
- Potential site work / ADA improvements.
