

## INTRODUCTION

**Overview**: The Department of Enterprise Service seeks qualified Architects for design and construction administration services. This project will restore the skylights in the House of Representative and Senate Chambers. This would include updates to the roof, skylight attic space and ceiling lights. It would also provide new lighting, upgrades to the sound system, upgrades to the fire and life safety systems, restoration of the bronze and glass ceiling lights, acoustical upgrades to the chambers, and some additional mechanical and structural work.

### SCOPE

### **Design and Engineering:**

- a. Prepare comprehensive design and engineering documents for the Skylight Restoration in accordance with DES Design Guidelines and Construction Standards.
- b. Provide proposed substitute material for consideration to replace the Skylights while maintaining historic view of the building.
- c. Coordination and providing all necessary documents to Authority Having Jurisdiction (AHJ) to obtain any required permits.
- d. Provide administration services during construction.



### **Construction cost estimate:**

Prepare accurate and itemized cost estimate for the skylight restoration project.

### **Stakeholder Engagement:**

a. Facilitate stakeholder engagement processes, including workshops, consultations, and collaborative meetings, to gather input and perspectives from relevant stakeholders, such as government agencies, Buildings & Grounds, energy consumers, environmental organizations, and the public.


b. Provide presentation materials for public meetings, the Capitol Campus Design Advisory Committee, the State Capitol Committee, Tribal partners, and the Department of Archeology and Historic Preservation (DAHP).

c. This project requires consultation with DAHP to evaluate potential adverse effect to the historic building and will require the consultant to interface with DAHP on the material selection, install method, etc., to best match historic materials.

## PROJECT GOAL'S

- The project will reestablish natural daylight to the Legislative Chambers as originally intended.
- Restore the Legislative Building's unique historic character as the building approaches its centennial celebration.
- This will include updating security, lighting, fire, and audio systems.
- Relocation of existing equipment to improve impact of the HVAC system(s) and light levels within each chamber.
- This work will enhance the facilities appearance, improve the functionality of the space, and make it safer by adding contemporary security features.
- Provide a historical experience for People who use the Legislative chambers and galleries.
- Design-Bid-Build is expected for the construction delivery method.

## **RFQ SUBMITTAL REQUIREMENTS**

- Max 15 total pages of content
  - $8\frac{1}{2} \times 11$  size sheets (oversized sheets count based on multiple equivalent of  $8\frac{1}{2} \times 11$  sheets)
  - Federal Form 330(part II only)
  - Any pertinent data to assist selection panel to evaluate the qualification
- Submit a single PDF (less than 25 MB in size)
- Note in the RFQ, the elements not counted towards the total page count (i.e., <u>covers, dividers, etc.</u>)

## PHASE 1 RFQ EVALUATION CRITERIA

  - Qualifications of Key Personnel (35 points);
  - Relevant Experience (35 points);
  - Past Performance (30 points);
  - Diverse Business Inclusion Plan (Pass/Fail)
- Focus
  - Skylight replacement experience
  - Historic site experience
  - Wide variety of stakeholder involvement experience
