Subject: PRC Letter of Interest Representing General Owner/Public

I am interested in continuing my service on the Project Review Committee (PRC) representing General Owners. I am currently the Executive Project Director for Sound Transit's \$2.4 billion, Federal Way Link Extension, design build project. The Federal Way Link Extension is a 7.8-mile project extending from the Angle Lake Station in the City of Sea Tac to the City of Federal Way.

From 2010 -2016, I was the Design and Construction Contracts Director for Sound Transit, responsible for the planning, procurement, administration and close out of various complex architectural/engineering and construction contracts that include GC/CM and Design Build for capital construction projects related to heavy rail, light rail, systems, and facilities valuing in excess of \$15 billion. From 2001 through March 2010, I served as the City of Seattle's Director of Contracts.

My thorough knowledge of laws and regulations governing public works contracting is demonstrated by the following achievements and responsibilities: manage staff responsible for solicitation, award, execution, contract administration and close out of public works, alternative public works; and A&E contracts; developed and implemented strategies to ensure contracting activities are efficiently and effectively conducted; developed, implemented, and managed the small works roster; responsible for social equity requirements on public works projects for the City of Seattle; and provided oversight of all contracting activities and assured consistency with legal and regulatory requirements. I present at regional training events related to public works contracting and alternative public works, including serving as an instructor for the AGC's GC/CM two day workshop.

I currently serve on the Design Build Institute of America (DBIA) national board, the Capital Projects Review Board (CPARB) representing Transportation, and the Project Review Committee (PRC) representing General Owners. I am a founding member of the Conference of Minority Transportation Officials (COMTO), WA Chapter, whose mission is to ensure a level playing field and maximum participation in the transportation industry for minority individuals, businesses and people with disabilities. I was honored to serve as chair of CPARB's GC/CM Heavy Civil Committee which successfully passed heavy civil legislation that became effective in 2014. I am now honored to serve as chair of the WSDOT Project Delivery Method Review Task Force.

I am excited at the opportunity to continue to represent General Owners, on the PRC and thank you for your consideration.
