8:00 am BUSINESS MEETING

Chair: Kyle Twohig\Jessica Murphy

A Committee quorum of 26 members were in attendance with 7 absences.

- Bylaws Update Action
 - Jim Dugan is lead for the Bylaw Subcommittee and the team hasn't had a chance to meet due to workload but plans to meet before the May PRC meeting.
 - Chair Twohig will forward a copy of the AG training recording from September 22, 2022 to him.
 - Chair Twohig asked for a vote on the update to the Bylaws Article 10 by removing "any meeting involving" from the second paragraph item 2 and after the last paragraph to include "Recused PRC members are allowed to participate in presentations to the PRS as representatives of their employer/agency." Tim Thomas moved to accept the changes; Becky Barnhart seconded the motion. Unanimous Approval.
 - The May 23, 2024, PRC meeting will be the in-person hybrid meeting at the Spokane Talbot Event Center!
 - Chair Twohig wanted to make sure all applicants know that in-person attendance is optional but need to identify if they do plan to attend.
 - Talia will send out the Statewide Vendor Payment System link so anyone wanting to travel and claim reimbursement will already be in the system. (This is half the hold up for getting reimbursement.)
 - Talia reminded the Committee that Vice Chair Elections also happen in May. A brief letter of interest or email would be helpful for Committee consideration.
- Recruitment for PRC vacancies and expiring positions
 - Chair Twohig shared the current recruitment status for this years' expiring positions. He encouraged anyone wanting to renew their membership to get their letter of interest sent into the PRC inbox as soon as possible. He also encouraged all members to reach out to their local contacts for anyone who may be interested and qualified to apply.
 - Talia explained that CPARB's Board Development Committee has been reviewing the PRC position names for consistency, will possibly be adding more Owner positions in the future to help balance the Public vs. Private representation on the Committee, and the realignment of position expirations so each stakeholder group position expiration dates are spread out and not all expiring the same year. This thought is to allow for experienced membership to mentor incoming membership, and to provide consistency in the annual PRC appointments by CPARB.
- CPARB update
 - Spokane Public Facilities District filed an appeal on their project denial to CPARB. CPARB held a special meeting on February 20, 2024, and overturned the PRC decision by 11/16 votes. One of the appeal factors brought up by Spokane PFD on the original denial noted that some of the written reasons for the denial were not based on statutory criteria.
 - There was a question about who represented the PRC at the appeal. Talia explained the basic process that CPARB used to review the appeal and shared a link for those interested to the CPARB February 20, 2024 event page: https://des.wa.gov/about/news-center/events/2024-02/cparb-special-meeting.
 - Chair Twohig reminded the Committee that it is vital that the scoring and comments be based on the statutory criteria. Complaints to CPARB come up whenever members stray from scorable criteria.
 - There was discussion about the appeal process and a request that the committee consider reviewing comments that are considered not within the scorable criteria. The names of the member could be removed and only the comments consolidated

into a document for discussion may be helpful in clarifying where the review process is breaking down.

- There was also a request to consider proposing a review of the appeal process to CPARB so there isn't the appearance of PRC being in conflict with CPARB in the eyes of the construction community. PRC decision appeals are very rare and usually applicants make improvements to their applications and then return with a more successful project.
- This is an opportunity to ask CPARB to come and brief the PRC on the appeal to better understand what CPARB saw as the justification for overturning the PRC decision. This would also help the PRC understand the current appeal process and possibly discuss useful mutual adjustments moving forward. This could help the PRC feel heard during the appeal process.
- Chair Twohig noted this is also a good reminder that it's very important for panel members to review the applications and submit advanced questions that can help guide the Owner-applicant to be successful.
- Mentoring Session / Panel Chair Training
 - Chair Twohig noted that along with mentoring new members as they come on this summer, he offered an opportunity for Panel Chair-Specific training. Panel Chair assignments are spread across the Committee as much as possible, and being a review panel chair is not a requirement. If a member is assigned, but is uncomfortable in that role, please let Talia know and she will identify a replacement. Anyone interested in being a panel chair is encouraged to reach out to on that Talia as well. Vice Chair Jessica Murphy has offered to mentor those interested in panel chair training. New members are not assigned within their first year of membership.
- Representing Your Stakeholder Group
 - In preparation for reviewing an application, Vice Chair Murphy reminded the committee members to consider your individual role and stakeholder group.
 - There was a question on what is considered non-scorable criteria. The example provided was Best Practices vs. RCW requirements. Applicants not using current best practices are not necessarily a reason to decline an application vs. scoring by scorable criteria.

- Project Cost: \$95.4M
- Design and construct a new 95,700 square foot K-12 school with elementary, middle, and high school educational/support facilities from two school sites into a consolidated campus located on higher ground and out of the tsunami zone of Neah Bay.
- Onsite parking, sidewalks, bus and fire loop traffic circulation and play fields will be included.
- \$1.6M was allotted for concept design by OSPI, and upon approval by the OSPI Seismic Committee, the full grant funding under OSPI School Seismic Safety Grant will be released.
- Project Team has knowledge and capacity for success.
- Project meets the RCW requirements.

Public Comment:

Curt Gimmestad with Absher Construction. He wanted to take an opportunity to as a general contractor, a design builder, and a Design-Build partner to express our support of this particular project in a Design-Build delivery model. Looking at RCW 39.10.280, 300, and 320 regarding substantial fiscal benefit over Design-Bid-Build, he can't imagine doing this project as a Design-Bid-Build while trying to manage the risk of the locale. topography of where this particular site is where the Olympic Mountains and the hills roll down into the Neah Bay community down there. You can get an idea of some of the challenges of this site. The other piece of this is Design-Build approach is critical in developing a construction methodology. It will be critical in developing the design and construction methodology and support on how to get this project done efficiently. The schedule will need to be efficient in particular and managing the risk on the back end from a locale that located out on the point. It's important to take into consideration that it takes a while to travel there, it's one road, and the weather can be pretty challenging throughout most of November through May. And the last piece of this, with regards to what Superintendent Parkin had alluded to, the development of a team and understanding how to bring on a Design-Build partner. Most importantly, this project is not just about the the school district, but it's about the Makah community and the slide that was talking about WMBE strategy, training, CTE and jobs. He can't imagine having to use Design-Build and being able to capture the opportunities that are there to support what is a pretty significant project for the Makah community. So they are in favor of this particular project going Design-Build.

Becky Wall *with Rice Fergas Miller Architects.* They were mentioned in the presentation as being the architecture partner for phase one of the project. She wanted to speak a little bit to the last question the panel had regarding the decision-making process with regards to the school district, and the Makah tribe and council. Her team was able to see firsthand their ability to quickly make decisions and get on the same page within those meetings. They were originally looking at one parcel of land, and then quickly realize that they needed to look at another. The tribe worked quickly with the school district to figure out where that parcel would be. She's worked with a lot of tribes and various partnerships and hasn't seen quite the swiftness she experienced from Michelle's team and the Makah Tribal Council. She wanted to share that she has no concern for them to be able to make those decisions quickly. And of course, her firm shares support for this to be a progressive Design-Build project. They've done projects out on the coast. particularly K-12 projects, and the Design-Build methodology is critical to delivering this type of project. The rainy season was mentioned as well as being able to get that work done in a short window. The Design-Build method has been helpful to making that happen with very few delays of the project due to missing that window. She feels Design-Build is a critical component to successful completion within the scheduled timeframe.

Layne Alfonso with GeoEngineers. He's in support of this project, and it's goal of relocating critical facilities for the community to safe place. He believes the team that they have assembled is more than capable of making sure that this project is done successfully. And progressive Design-Build is an appropriate delivery model for the for this project.

Deliberation:

This project meets all the RCW criteria, has an experienced team, and this project will meet the needs of the community.

- Project rehabilitation of up to 15 miles of the middle section of Pipeline 1 and is critical for completion of other work in Tacoma's Pipeline 1 Pressurization Program. Construction will be at or near the existing Fennel Creek 705 Pump Station along with corresponding remote-site improvements that will provide an estimated 6,300 gpm initially and expandable to 8,500 gpm of drinking water to the Prairie Ridge, Tehaleh, and Cumberland service areas.
- Project if fully funded using a combination of bonds, low-interest loans, capital and operating reserves.
- Project meets all RCW requirements for Design-Build.
- Project team has been augmented with highly qualified consultants.

Public Comment:

Jim Dugan with Parametrix.

He represent Parametrix, a private consultant, and probably 2 and a half decades of working for multiple departments within the city of Tacoma, as well as working on projects collaborating with Robynne Thaxton and other members of the team. He wanted to comment on the competency and the talent that lies within what is Terry Forslund, and what is Alicia Flatt. At a minimum, both are extremely competent, detail-oriented, an excellent client, and pay attention to detail. They ramp faster than anybody else he knows, and they sit at the top of the pile of clients for those that actually say what they do and do what they say. While there has been some questions in terms of talent that lies specifically within Alicia, he can attest that she can handle anything that comes her way. She's ready for what it lies ahead of her, and she's flanked by talent, and that talent is exceptional.

The team provided a good presentation and provided thoughtful responses. This project meets the RCW criteria, and has the appropriate support mechanisms in place for success.

- Camas Meadow Park & Plante's Ferry Sports Complex (Phase 1 Improvements) Project

- Project Cost: \$11M
- This is a combined project between the creation of a new 10-acre park with parking, utility extensions, restrooms, shelters, a playground, field space, etc. and the redevelopment of the Plante's Ferry Sports Complex to include 3 synthetic turf multi-purpose fields, new entry drive with intersection improvements, field lighting, new parking lot, perimeter fencing and stormwater facilities.
- Funding was secured via Spokane County's 2022 American Rescue Plan and approved by Spokane Board of County Commissioners in November 2022.
- The project team is qualified and has capacity.
- Project meet RCW criteria.

Public Comment:

Ryan Kirkpatrick *with eastern WA Skanska USA.* They feel this is a pretty good use of progressive Design-Build and being able to target value design with that design team early on. Then the team can move in to maximize the scope of this project to be able to utilize it at the Plante's Ferry job and then making sure that the Camas Meadow project is getting due justice as well. Doing a Design-Build team for both projects is a good idea.

Bill Helbig. *Director of Spokane Valley Public Works*. He's the public works director for City Spoken Valley. He wants to provide just a few comments and their full support for the county's effort in these parks projects especially the Plante's Ferry complex improvements. The Plante's Ferry Complex is immediately adjacent to, and almost directly in the middle of the city of Spokane Valley. With this location, the complex and its continued operation is extremely important to the city. Outside of our residents using the complex routinely as part of their everyday lives, events at the complex drive tourism dollars within our city, as event participants use our hotels, restaurants, and other services. The complex is a key asset to our community, and our Council continues to recognize its importance by providing funding for the Master Plan development as Julie noted in her presentation. On a more technical level, the city is currently managing 2 progressive Design-Build projects, the repair of City Hall and the recently approved Flora Road Cross Country Course Complex. He believes the county's proposed use of progressive Design-Build for these park projects is appropriate. Plante's Ferry, for example, will need to have critical scheduling and project construction phasing clearly followed as it's necessary for the park to be usable during construction. The progressive Design-Build efforts allow for the best chance of this project's success. In summary, the city fully supports the county's efforts for these projects, and they are looking forward to their final completion.

Rob Decker *with Garco Construction.* He lives in Spokane and wanted to mention his support. He echoes Ryan's sentiments. He feels both projects will serve the owner and the taxpayers well. Using progressive Design-Build hits the requirements of RCW 39.10, and he supports this project.
