BE/DBI Change Order Workgroup Survey Questions Regarding Changes

In 2022 the BE/DBI Committee conducted a survey of items that cause failure of prompt payment for contractors on public works projects. One area that was identified was the change order process. Change order types, change order process, and payment for changes vary greatly from project to project. It is common on projects to experience confusion and lack of understanding with the change process, which often leads to late, partial or no payment for executed change work. This follow-up survey is provided to determine how best to improve the change process on public projects.
