



### Jail & Justice Center Project Overview

- Jail Population has increased by 18% YoY
- •Current Average Daily Jail Population: ±71 (Males: ±61 & Females: ±10)
- Overcrowded, No Visitation, No Access to Natural Light/Fresh Air
- November 2023 Voters Approved +0.4% Sales Tax Increase
- Planning 140-bed Jail Facility with Courts, Clerk's Offices & Admin
- Site Development and Challenges
- Demolition of Existing County Building & Associated Relocation
- Existing Utilities Traversing Site
- Poor Soils, Existing Waterway & High Water Table

## Why ECCM/MCCM

- Electrical Scope including Security Electronics is Complicated
- Mechanical scope needs to align with Electrical scope early in the project
- Contract size for M/E is very large for this geographic region
- Ability to procure long lead items & start early work packages
- Continuous Cost Estimating
- Coordination and planning of Jail security is critical
- Coordination of activation and transfer to new facilities
- Coordination of Jail Cells for Mechanical and Electrical

### **MWBE Outreach**

- •Will be the first alternative delivery project for County
- Scoring criteria through selection process plan & track record
- Work with OMWBE to get scopes of work out to as many as possible
- Ongoing subconsultant outreach
- Partner with AGC and GCCM for outreach opportunities
- APEX coordinator coordination
- As a rule, the County is focused on MWBE/DIVERSITY when feasible for each purchase & subcontractor relationship
