 - Report to the Governor and the Legislature annually by October 31

IT CONTRACT REPORTING PROVISO, CONT.

- Enterprise Services must collaborate with WaTech –
 - To provide statewide IT contract information, including contract spending projections for each ensuing state fiscal year through the contract term
 - For all contracts for all agencies
 - Report to the Governor and the Legislature annually by October 31

(4) Within existing resources, beginning October 31, 2021, the department [of Enterprise Services], in collaboration with consolidated technology services, must provide a report to the governor and fiscal committees of the legislative by October 31 of each calendar year that reflects information technology contract information based on a contract snapshot from June 30 of that same calendar year, and must also include any contract that was active since July 1 of the previous calendar year. The department will coordinate to receive contract information for all contracts to include those where the department has delegated authority so that the report includes statewide contract information. The report must contain a list of all information technology contracts to include the agency name, contract number, vendor name, contract term start and end dates, contract dollar amount in total, and contract dollar amounts by state fiscal year. The report must also include, by contract, the contract spending projections by state fiscal year for each ensuing state fiscal year through the contract term, and note the type of service delivered. The list of contracts must be provided electronically in Excel and be sortable by all field requirements. The report must also include trend analytics on information technology contracts, and recommendations for reducing costs where possible.

A provision "to require that each vendor agrees to equality among its worker by ensuring *similarly employed* individuals are compensated as equals"

Similarly Employed Means:

"Employees are similarly employed if the individuals work for the same employer, the performance of the job requires comparable skill, effort, and responsibility, and the jobs are performed under similar working conditions." See ESHB 1109, §150(6)(a)(i)

 - Tasks OCS, in collaboration with the AGO, to research existing best practices for data governance and data protection, including model terms for data sharing contracts, and submit a report to the Legislature by December 1, 2021.
 - Exempts cybersecurity reports provided to the Governor from the Public Records Act.
- Amends
 - RCW 39.26 State Procurement Code for Goods/Services to:

- Repeals the Office of the Attorney General's authority to investigate and enforce prohibited and unlawful acts pertaining to the certification of, and contracting with, minority- and women-owned businesses.
- Requires OMWBE, annually, to identify state agencies and educational institutions with low levels of public contracting participation by minority and women-owned businesses.

Impacts:

- Provides the Office of Financial Management (OFM) the authority to waive some or all predesign requirements on capital projects exceeding the \$10 million threshold.
- Requires the OFM to notify the legislative fiscal committees of any waivers.

SSB 5152 — DATA STEWARDSHIP & PRIVACY PROTECTIONS FOR VEHICLE AND DRIVER DATA

Passed

Enacted

- **SSB** 5152
- Governor signed May 16, 2021
- See Laws of 2021, ch. 93
- Effective: July 25, 2021

- Requires the Department of Licensing to contract with an entity authorized to receive personal or identity information that must include limitations for the use of this information, requirements that the data recipient allow regular use audits and undergo regular data security audits, and provisions governing redisclosure of this information.
- Establishes a civil penalty for the unauthorized disclosure or use of personal or identity information of up to \$20,000 per incident.
- Expands government access to personal and identity information for any request related to the carrying out of governmental functions, except for requests that target Washington residents solely on the basis of race, religion, immigration or citizenship status, or national or ethnic origin.
- Expands access to driving abstract information to transportation network companies, as well as to state agencies and scientific research organizations conducting research.

Enacted

- **E2SHB 1365**
- Governor signed May 13, 2021
- See Laws of 2021, ch. 301
- Effective: July 25, 2021

- Objective: Equip students and staff with computers.
- Amends <u>RCW 28A.650</u> Common School, Education Technology
 - Requires educational school districts to provide specified technology, consultation, procurement, and training.
 - Enables ESDs to perform technology procurement in consolation and contract with Enterprise Services.
 See E2SHB 1365 at §3(3)(c).

SB 5146 – FISH & WILDLIFE COMMISSION INDEMNIFICATION AUTHORITY

Passed

■ House: 97-0

Senate: 49-0

- Enacted
 - SB 5146
 - Governor signed May 3, 2021
 - See Laws of 2021, ch.
 182
- Effective: July 25, 2021

- Objective: Provide the Fish and Wildlife Commission will authority to enable it to indemnify the United States and its agencies as a condition to secure federal funds for fish, shellfish, and wildlife projects.
- Amends <u>RCW 77.12.320</u> to add the following:
 - "(4) The commission may indemnify the United States and its agencies as a condition of securing federal funds for purposes of fish, shellfish, and wildlife projects."

E2SSB 5022 — MANAGEMENT OF CERTAIN MATERIALS TO SUPPORT RECYCLING AND WASTE LITTER REDUCTION

Passed

House: 73-24

Senate: 31-18

- Enacted
 - **E2SSB 5022**
 - Governor signed May 17, 2021
 - See Laws of 2021, ch. 313
- Effective: July 25, 2021

 Objective: Establishes minimum postconsumer recycled (PCR) content, registration, and reporting requirements for producers of plastic beverage containers, household cleaning and personal care product containers, and plastic trash bags (covered products)

- Impacts:
 - Requires state agencies to purchase plastic trash bags only from plastic trash bag producers that comply with minimum recycled content requirements.
 - Restricts the sale of expanded polystyrene cold storage containers and food service products beginning June 1, 2024, and void filling packaging products beginning June 1, 2023.

ESHB 1273 – Menstrual Hygiene Products In Schools

■ House: 85-12

Senate: 43-5

Enacted

- **ESHB** 1273
- Governor signed May 3, 2021
- *See* Laws of 2021, ch. 163
- Effective: July 25, 2021

- Requires school districts, private K-12 schools, charter schools, state-tribal compact schools, and public and private institutions of higher education to make menstrual hygiene products available at no cost by the beginning of the 2022-23 academic year.
- Requires these entities to bear the cost of supplying these products.

ESSB 5203 — PRODUCING, DISTRIBUTING, & PURCHASING GENERIC PRESCRIPTION DRUGS & INSULIN

Passed

■ House: 66-31

Senate: 28-21

- Enacted
 - **ESSB 5203**
 - Governor signed May 12, 2021
 - *See* Laws of 2021, ch. 274
- Effective: July 25, 2021

Objective: Reduce the cost of prescription drugs & insulin

- Impacts:
 - Authorizes the Health Care Authority to enter into partnership agreements with other states, state agencies, or nonprofit entities to produce, distribute, or purchase generic prescription drugs and purchase and distribute insulin.
 - Requires state purchased health care programs to purchase generic drugs and insulin through any available partnerships and allows other entities to purchase through a partnership voluntarily.

2SSB 5192 — Access to Electric Vehicle Supply Equipment

Passed

House: 56-42Senate: 30-19

Enacted

- **2SSB** 5192
- Governor signed May 10, 2021
- See Laws of 2021, ch.
 238
- Effective: July 25, 2021

- Requires electric vehicle service providers to clearly disclose the costs of using publicly available electric vehicle supply equipment.
- Requires the Washington State Department of Agriculture, in consultation with the Department of Commerce and the Utilities and Transportation Commission, to adopt rules for certain publicly available electric vehicle supply equipment regarding payment methods, interoperability, and the sale of electricity as a vehicle fuel.
- Establishes registration fees and penalties related to electric vehicle supply equipment.

SHB 1170 — BUILDING ECONOMIC STRENGTH THROUGH MANUFACTURING

Senate: 48-0

Enacted

■ SHB 1170

Governor signed April 16, 2021

• *See* Laws of 2021, ch. 64

Effective: July 25, 2021

 Objective: Provides a state goal to double the state's manufacturing employment base, the number of small manufacturing businesses, and the number of women and minority-owned manufacturing businesses in 10 years

- Requires the Department of Commerce to:
 - Prepare a biennial report to the Legislature on the state of the manufacturing and research and development in Washington;
 - Convene a manufacturing council to advise and consult on the biennial report and its recommendations; and
 - Appoint a workforce innovation sector lead.

EHB 1199 – DNR LEASES

Enacted

EHB 1199

Governor signed April 14, 2021

• See Laws of 2021, ch. 36

Effective: July 25, 2021

- Requires the Department of Natural Resources (DNR) to compensate lessees in the event that the DNR exercises a nondefault or early termination provision in a state land lease for agricultural or grazing purposes.
- Establishes compensation formulas for agricultural leases and for grazing leases.
- Creates certain additional obligations for the DNR in the event that the DNR exercises a nondefault or early termination provision in a state land lease for agricultural or grazing purposes.

SHB 1424 – SALE OF DOGS & CATS

Passed

House: 68-30

Senate: 31-18

- Enacted
 - SHB 1424
 - Governor signed April 16, 2021
 - *See* Laws of 2021, ch. 76
- Effective: July 25, 2021

- Impacts:
 - Prohibits a retail pet store from selling cats.
 - Prohibits a retail pet store from selling dogs unless the pet store sold dogs prior to the effective date of the act.

 - Creates Small Business Procurement Preference (add new section to <u>RCW 39.24</u>): 3% of all public contracts that are exempt from competitive bidding requirements
 - Amends <u>RCW 28B.10</u> (HigherEd); <u>RCW 39.04</u> (Public Works); <u>RCW 39.26</u> (Goods/Services); and <u>RCW 39.80</u> (A&E)

SHB 1204 – Transportation Electrification

 - Establish a goal for the state that publicly and privately owned passenger and light-duty vehicles of model year 2030 and later sold, purchased, or registered in Washington be electric vehicles.

SSB 5333 – Void & Unenforceable Clauses in Public Works Contracts Relating to Delays Caused by Covid-19 Pandemic Emergency Proclamations

 [Void & unenforceable construction contract provisions]
- Objective:
 - Declare that, as to public works contracts, any contract provision that purports to waive, release, or extinguish a contractor/ subcontractor/ supplier's rights to damages or an equitable adjustment rising out of a delay in performance caused by the Covid-19 pandemic emergency proclamations is against public policy and is void & unenforceable.

SB 5366 - BUY CLEAN & BUY FAIR WASHINGTON ACT

 - Beginning July 1, 2021, would require 'awarding authorities' (including Enterprise Services) to require their contractors on 'covered projects' to submit certain specified data, including an Environmental Product Declaration (EPD) and labor rights data for each 'covered product' used.

HB 1280 – GHG Emission Reductions in Public Facilities

- Would amend <u>RCW 39.35</u>
 [Energy Conservation in the Design of Public Facilities]

 - Must consider the use of all-electric energy systems and at least one renewable energy or combined heat and power system.

HB 1308 — EXPANDING APPRENTICESHIP UTILIZATION REQUIREMENTS

 - Require municipalities to monitor and report their apprentice utilization hours by contractor.

SSB 5116 — PROCUREMENT & USE OF AUTOMATED DECISION SYSTEMS

- Status
 - Original Bill (Jan. 8, 2021)
 - Substitute Bill (Feb. 8, 2021)
- Notes:
 - Similar bill was introduced last session.
 See SHB 1655 & SB 5527

- Would amend <u>RCW 49.60</u> [Discrimination] & <u>RCW 43.386.901</u> [Facial Recognition]
- Objective:
 - Require the Washington state CIO to adopt rules regarding the development, procurement, and use of automated decision systems by a public agency.
 - Require public agencies to develop an algorithmic accountability report that meet certain requirements on the use of automated decision systems.
 - Expand Washington's Law Against Discrimination (RCW 49.60) to prohibit discrimination by automated decision systems.
 - Delay effective date of last year's Facial Recognition Act (RCW 43.386) to July 1, 2026.


USEFUL BILL INFO, CONT.

- Bill: A proposed law presented to the Legislature for consideration
- Pre-filed Bill: A bill which is submitted for introduction/first reading before the legislative session begins (pre-filed bills are introduced on the first day of the session)
- Companion Bill: A bill introduced with the same language in both the House and the Senate
- Substitute Bill: A version of a bill offered by a committee in the first chamber. If adopted, the substitute replaces the original bill or resolution

- Striker or Striking Amendment:
 Amendment removing everything after the title and inserting a whole new bill
- Engrossed Bill: A bill which reflects all amendments made in the house of its origin
- Enrolled Bill: A bill passed by both houses, which incorporates all amendments, and to which has been attached a certificate of enrollment indicating the date passed, votes cast on the bill, and the certifying officers' signatures. It is presented to the Governor for signature
- Act: A bill adopted by the Legislature

How a BILL BECOMES A LAW

- A bill may be introduced in either the Senate or House of Representatives by a member.
- The bill is referred to a committee for a hearing. The committee studies the bill and may hold public hearings on it. It can then pass, reject, or take no action on the bill.
- The committee report on the passed bill is read in open session of the House or Senate, and the bill is then referred to the Rules Committee.
- The Rules Committee can either place the bill on the second reading calendar for debate before the entire body, or take no action.
- At the second reading, a bill is subject to debate and amendment before being placed on the third reading calendar for final passage.
- After passing one house, the bill goes through the same procedure in the other house.
- If amendments are made in the other house, the first house must approve the changes.
- When the bill is accepted in both houses, it is signed by the respective leaders and sent to the governor.
- The governor signs the bill into law or may veto all or part of it. If the governor fails to act on the bill, it may become law without a signature.
