

## **Ex. 1 to Reauthorization Committee Report to CPARB for Meeting on December 11, 2019**

### **Timeline**

#### **Updated at RA Committee Meeting on December 2, 2019**

**November 2019** – JLARC review (Subcommittee?); legislative resources [**NOTE:** this task has not begun as of 12/2/19]

**December 2, 2019** – Committee to receive update and proposed timeline for final recommendations from Business Equity/Diverse Business Inclusion Committee (Equity/Diversity Committee) and GCCM Committee.

**December 11, 2019** – Update CPARB on progress and timeline.

**January through March 2020** – Committee meets monthly. Meetings to be scheduled following establishment of GC/CM Committee Schedule. Schedule of issues to address as follows:

January – JOC open items; CPARB Membership open items; CPARB role open items;

February – Accountability; Sunset Review; Fairness and Transparency in selection;

March - GCCM proposals; Diverse Business Inclusion/Business Equity proposals.

**February CPARB meeting** – Committee to provide CPARB update on any draft statute changes, list of open issues.

**January – February, 2020** - Committee to work on legislative strategy and developing resources to support reauthorization; Committee to work jointly on proposed recommendations from other committees as needed.

**March TBD, 2020** – Target Date for Committee to receive final recommendations from GCCM Committee and Equity/Diversity Committee and any written legislative proposals; begin process of incorporating proposals/recommendations into bill.

**March 2020 – May 2020** – Committee to meet every other week or as needed to determine which written proposals will be included in the draft bill and to draft, refine and coordinate draft changes.

**May 2020 CPARB Meeting** - Committee presents draft bill to CPARB for input

**Summer 2020** - CPARB members, Committee and stakeholders solicit stakeholder feedback; Committee preps for JLARC review; seeks legislative sponsors.

**September 2020 CPARB Meeting** – Committee to present any updates to CPARB, Committee to receive additional Board feedback.

**September 2020 – December 2020** – Committee addresses issues in preliminary JLARC report, determines if changes are needed to address JLARC issues, continue refining legislative strategy and confirm sponsorship.

**December 2020** – CPARB votes on bill for introduction.

**January 2021** – Bill introduced and supported by CPARB and stakeholders.

**TBD:** Timing for AGO review Code Revisor

**High Level JLARC Review Timeline [Note: this schedule is dictated by JLARC and is provided for information]**

- December 2019/ January 2020 – JLARC staff begins review and report preparation
- July/August - CPARB Chair provides technical review of confidential JLARC draft
- Mid-September – JLARC staff present preliminary report to JLARC
- November 2020 - CPARB chair provides formal response, which is incorporated into final report
- December - 2020 proposed final report presented to JLARC
